



## How to sign in online in support for or in opposition to a House Bill or Senate Bill in New Hampshire

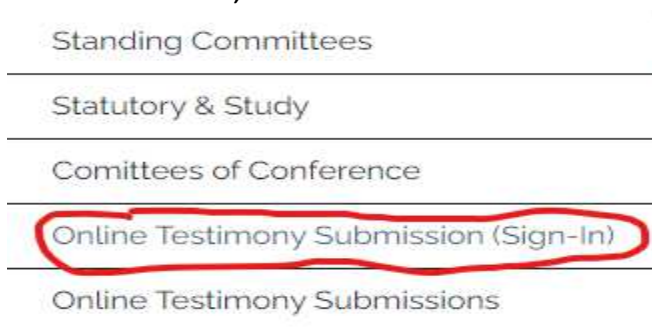
### New Hampshire House Bills

Follow the steps below to successfully sign in support of or in opposition to House Bills (HB), and/or if you would like to submit testimony online.

1. In the search bar type in <https://www.gencourt.state.nh.us/house/> (or copy and paste the link provided).
2. Once the page has loaded, hover your cursor over the “Committees” tab.



3. A menu will show up below the “Committees” tab showing several options. Hover down to, then left-click on “Online Testimony Submission (Sign-In)”.



4. After doing that, the screen below should show up. Fill out your personal information in the spaces provided.

5. Select the date that the hearing will occur.
6. Select the committee that is hearing the bill, then the bill itself in the next box.
7. Under “I am” select who you are representing. If you are putting in your own opinion, select “A Member of the Public”.
8. In the next space, fill in what organization, legislator, town, or branch you are representing. If you are representing yourself, write “myself”.
9. Indicate your position on the bill by clicking on the bubble to the left of the position you have on the bill.
10. If you are submitting testimony, complete Step 4 by either uploading your pre-written testimony or writing in your testimony in the space provided. If you are not, you may skip Step 4.
11. Click “Submit” under “Step 5. Final Review” when you are done to submit your stance to the House.

## New Hampshire Senate Bills

Follow the steps below to successfully sign in support of or in opposition to Senate Bills (SB), and/or if you would like to submit testimony online.

1. In the search bar type in <https://www.gencourt.state.nh.us/senate/> (or copy and paste the link provided).
2. Once the page has loaded, left click on the “Committees” tab.



3. A menu will show up below the “Committees” tab showing several options. Hover down to, then left click on “Remote Sign In”.



4. Select the date that the hearing will occur.
5. Select the committee that is hearing the bill, then the bill itself in the next box.
6. Under “I am” select who you are representing. If you are putting in your own opinion, select “A Member of the Public”.
7. Indicate your position on the bill by clicking on the bubble to the left of the position you have on the bill.

8. Click “Continue” at the bottom of the page when you are done with this section.
9. After doing that, the screen below should show up. Fill out your personal information in the spaces provided.
